## INTRODUCTION

- Political declaration on corruption compliments review of implementation of UNCACsee para 76, 77, 81 and 83 of the political declaration on corruption
- Nigeria has been reviewed on the two review cycles and the country reports have been completed and the full reports posted on UNODC website
- Some recommendations in the report have been implemented while others are on going

## PREVENTION

- National Anti-Corruption Strategy (NACS) is linked to SDGs and national development.
- Enactment of Nigerian Financial Intelligence Agency Act (NFIA) 2018 grants autonomy and independence to NFIA
- Anti-corruption academy of ICPC and EFCC gives training and engage in public awareness
- Adoption of Beneficial Ownership Transparency disclosure; NEITI, PIA and CAMA
- Code of Conduct Bureau Bill before the National Assembly makes provision for public disclosure of asset and on-line asset declaration
- Review of some e-Governance initiatives e,g Integrated Payroll and Personnel Information System (IPPIS.
- Corruption measuring tools e.g Nigeria corruption survey, Ethics and compliance scorecard, Corruption Risk assessment and System Studies & Review

### **CRIMINALIZATION AND LAW ENFORCEMENT**

- The Administration of Criminal Justice Act (ACJA) 2015 introduces good innovations e.g plea bargain, out of court settlement, limited adjournments, trial in absentia, restitution and victim compensation, non-custodial sentencing, remove stay of proceedings and ACJA Monitoring Committee.
- Court of Appeal and Supreme Court Fast track Practice Directions grant accelerated hearing to appeals relating to corruption, terrorism and human trafficking.
- Whistleblower and witness protection Bill is before the National Assembly

## CRIMINALIZATION AND LAW ENFORCEMENT CONT'D

- The new Money Laundering (Prohibition) Act 2022 expanded predicate offences to include illicit enrichment or unexplained wealth and established Special Control Unit against Money Laundering (SCUML)
- Enactment of Cybercrime (Prohibition and Prevention ) Act, 2018
- Adoption of sentencing guidelines

### ASSET RECOVERY AND RETURN

- Enactment of Proceeds of Crime (Recovery and Management) Act 2022 –civil forfeiture, value-based asset forfeiture, admits hearsay evidence.
- Development of asset disposal guidelines
- Development of data base of confiscated asset
- Participation of society in the disposal of forfeited assets
- Constituency and Executive Project Tracking Group (CEPTG)

#### INTERNATIONAL COOPERATION

- Enactment of the Mutual Legal Assistance Act, 2018
- Developing case management system on MLA
- Membership of GlobE Network
- Accession to cybercrime convention
- Reciprocity as basis for MLA
- Developing MLA guidelines
- UNCAC as a basis for extradition and MLA
- Inter-agency committee on Illicit Financial Flows
